Office of the Accountant General (Audit), Tripura is proposing to dispose of one Govt. vehicles on "as is where is basis". Details of the said vehicle is as under:

2. Accordingly, sealed quotations are invited for the disposal of the said vehicle on the terms and conditions mention below. Persons/firms, interested in purchasing the above mentioned vehicle, may submit their quotation in the enclosed Proforma in a sealed cover addressed to the undersigned latest by 5:00 pm on or before 05.03.2019 at Office of the Accountant General (Audit), Tripura, Agartala. The bidders or their representatives may be present, if they so desire, at the time of opening of Quotations. The cover should be prominently superscribed with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE Ambassador".

3. The vehicle will be available for inspection between 11.00 a.m. to 4.00 p.m in the office premises.

4. The Disposal of the said vehicles will be governed by the following conditions:

i. The vehicle will be sold on "as is where is basis". The bid opening process will be conducted in presence of Deputy Accountant General (Admn.).

ii. The bidders are required to pay Earnest Money of **Rs. 2000/-** (Rupees two thousand only).

iii. Earnest Money is payable by means of Demand Draft in favour of Pay & Accounts Officer, O/o the Accountant General (A&E), Tripura, Agartala (payment by cheque or cash shall not be accepted).

iv. Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.

v. The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of Pay & Accounts Officer, O/o the Accountant General (A&E), Tripura, Agartala within three working days of the acceptance of bid.

vi. The Earnest Money of the successful bidder will be adjusted in the bid amount and the car will be released only after depositing the residual bid amount. Earnest Money of the successful bidder will be forfeited, if he fails to honour the bid. In case of failure to deposit final bid amount, the vehicle may once again taken up for re-auction or go for second disposal.

vii. The delivery of the auctioned vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN Card, Aadhar Card etc. in case of individual and Registration Certificate etc. in case of firm).

viii. The auctioned vehicle will be removed by the successful bidder within 02 working days of depositing the bid amount, at their own expenses.

ix. The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this Department.

x. This Department will not owe any responsibility for transfer of vehicle and for any other liability for using this vehicle for commercial or any other purpose after sale.

xi. The successful bidder will also be responsible for getting Registration Certificate of the vehicle and/or any other documents as required by the RTO, in his name at his own cost expeditiously. This Office will not be responsible for any lapse on his part in this regard.

xii. If, the successful bidder wants to scrap the vehicle, then he should have to submit the cup part of the chassis number to this office immediately.

xiii. The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.

xiv. The undersigned reserves the right to accept or reject any or all of the quotations without assigning any reason.
